THE PROFESSIONAL DEVELOPMENT PROGRAM WAS PROVIDED IN PARTNERSHIP WITH THE STATE SUPERINTENDENT OF EDUCATION TO ENABLE TEACHERS TO LEARN HOW TO EFFECTIVELY TEACH MICROECONOMICS AND MACROECONOMICS. APPROXIMATELY 500 TEACHERS COMPLETED THE PROGRAM AND ARE PROVING THAT THE PROGRAM IS A TREMENDOUS INVESTMENT WITH A SIGNIFICANT RETURN TO THE HUMAN CAPITAL OF OUR STATE. STUDENTS ARE REQUIRED TO TAKE ONE SEMESTER OF ECONOMICS IN ORDER TO GRADUATE FROM HIGH SCHOOL. TEACHERS WHO PARTICIPATED IN THE PROGRAM EARNED A CERTIFICATE FROM THE STATE BOARD OF EDUCATION.
