THE PROFESSIONAL DEVELOPMENT PROGRAM WAS PROVIDED IN PARTNERSHIP WITH THE STATE SUPERINTENDENT OF EDUCATION TO ENABLE TEACHERS TO LEARN HOW TO EFFECTIVELY TEACH MICROECONOMICS AND MACROECONOMICS. 811 TEACHERS COMPLETED THE PROGRAM AND ARE PROVING THAT THE PROGRAM IS A TREMENDOUS INVESTMENT WITH A SIGNIFICANT RETURN TO THE HUMAN CAPITAL OF OUR STATE. OTHER MASTER TEACHER PROGRAMS FOR PERSONAL FINANCE ENTREPRENEURSHIP HAVE REACHED 487 TEACHERS. STUDENTS ARE REQUIRED TO TAKE ONE SEMESTER OF ECONOMICS IN ORDER TO GRADUATE FROM HIGH SCHOOL. TEACHERS WHO PARTICIPATED IN THE PROGRAM EARNED A CERTIFICATE FROM THE STATE BOARD OF EDUCATION. ON AVERAGE, TEACHERS RAISED THEIR SCORE ON A TEST OF ECONOMIC LITERACY BY APPROXIMATELY 40% AFTER THE TRAINING. IN ADDITION, HIGH SCHOOL STUDENTS INCREASED THEIR SCORES BY APPROXIMATELY 66% WHEN
